Veterans Memorial Dedication: Eighteen months ago, one of our Supervisors presented the idea of creating a Veterans Memorial, to be located by our new Township flag pole. Eagle Scout candidate, Zachary Sawdey, accepted the challenge! This would fulfill his project requirement for scouting’s highest honor. Zac, a former township resident, then proceeded to design, seek funding, manage, and provide much of the construction manpower for the creation of the memorial. With the aid of his family, friends, and fellow scouts, the project was completed in late summer, a few months before his project deadline. On this Veterans Day, we will salute our area Veterans, and celebrate the achievement of this fine young man. You are welcome to drive through the parking lot to view the finished project. We invite you to join us on Sunday, November 11, at 3:00 p.m. for a brief dedication ceremony and salute to our Veterans. A reception will follow in the Township Building.

Chelton Avenue project is scheduled for completion late this fall, including paving, and then be opened for public use! Thank-you everyone for your patience as this long project was challenging, due to so many intricate issues and funding mandates.

2018 Road Projects are nearing completion as the winter season approaches. These projects included, full depth reclamation of Rife Road and Summers Road, patching, crack sealing and pipe replacement on various township roads.

The underpass to the MYO ballfields, Borough Park, and Millersburg Water Authority facilities [officially West Pearl Street] has been temporarily repaired after this summer’s flooding. DEP accepts this as a short- term fix but is requiring a permanent solution in the near future. Studies and design are being explored, and Gaming Grant Funding is being sought. Where we probably can never totally prevent closure due to high water, our goals include public safety and Water Authority access to their plant, with minimal interruption. We will keep you updated.

Firewood Cutting in the Glen, Township Park, is available to Township residents, by securing a permit from the township office. Dead trees were cut down this summer and remain available to be further cut apart by residents at their own liability. Check with the township office to be sure that the ground is solid, since the summer rains have made parts inaccessible. Guidelines for cutting will be available when you secure your permit.

The Township Compost Center again is being misused by a few individuals who choose to deposit items that hamper the care and proper removal of the recycled material. This facility is an important service to our residents, and we seek ways to properly control its use. Large rocks, appliances and like items will cause damage to township equipment as well as that of our contractors. We are looking for ways to control the center's use and provide controlled access and video surveillance. We welcome your input.

The Township Parking lot has been paved and lined, insuring its longevity, and safety for all who use it. Also, the storm water drainage pond has been completed behind the new building, officially completing the two-year building project. Funds for both these projects were made available through Gaming Grants.

Zoning Ordinances have been in the lengthy process of being updated for several years, with the aid of County personnel. When these minor changes are complete, the public will have the opportunity to review and comment on them. The Supervisors emphasize the changes being made are for clarification only, and not designed to alter the pathway of township business.

Spring Cleanup Day for the Township is currently set for Saturday April 13, 2019. Mark your calendars!

Dauphin County Electronic Recycling has made some major changes, of which you need to be aware. Locally, the County receives items for recycling at the UPT garage on the second Saturday morning every month. This program is for residential use only. No businesses please. These are the ONLY ITEMS that will be accepted:

- *TV's All types (Must NOT be taken apart)
- *Central Processing Units (Desktop/Towers)
- *Laptops
- *Printers
- *Computer Keyboards
- *Computer Mouse
- *Computer Monitors (All types)
- *Cable or Satellite Boxes
- *Cords and Cables
- *Tablets/Kindles
- *Microwave Ovens
- *Gaming Systems (PlayStations/Xbox)

ALL OTHER ELECTRONICS OR APPLIANCES MUST BE BROUGHT TO THE DAUPHIN COUNTY RECYCLING CENTER.
