

**Upper Paxton Township Board of Supervisors
Monthly Meeting
June 27, 2018**

Those in attendance: Ron Hepner, John Orr, and Robert Stoner, Supervisors; Luanna Zimmerman, Secretary/Treasurer, and Diane Krug.

The meeting was called to order by Chairman Hepner at 10:00 a.m. All present recited the Pledge of Allegiance to the flag. Robert Stoner made a motion to approve the minutes from the June 12, 2018 meeting. Second by John Orr. With all in favor, motion carried. John Orr made a motion to pay the bills. Second by Robert Stoner. All in favor, motion carried.

Roadmaster's Report: Ron Hepner said that he had spoken with Roadmaster Erdman and reported the following: **1.)** Erdman is currently putting cuts on Rife Road for pipe installation. **2.)** John Hoffman is doing roadside mowing on Rife Road & Summers Road to prepare these roads for upcoming contracted road work. **3.)** Hepner said the roadcrew cannot finish the work on Matter Lane until the dump truck is repaired. **4.)** Erdman is inquiring to find out when the contracted road work is scheduled to be done. Ron Hepner also said that Terry Maiden had inquired about pot hole repair and dust suppressant for Charles Road. Hepner told the Board that he will speak with Roadmaster Erdman to find out what can be done. John Orr said that he and Ron Hepner had spoken with Chris Deitz and Chris McGann regarding road improvement work for Rising Sun Road for 2019. The Borough indicated that they will be working with their engineering firm for improvements to the Borough portion of Rising Sun Road.

Old Business:

1. Robert Stoner reported that the Veteran's Memorial Project, done by Zac Sawdey, is coming along nicely. Stoner said that the next step is to put a finish on the monument along with the plaques recognizing the 5 branches of the military. Some landscaping work will also be done. A dedication ceremony is being planned for Sunday, November 11, 2018.
2. The Board reviewed the proposed ordinance revisions with Diane Krug from the Tri – County Regional Planning Commission. Krug will work with Jerry Duke on making some changes and present them at a future meeting.

New Business:

1. Supervisors reviewed the plans and the County comments for the Thomas White subdivision. John Orr made a motion to approve this subdivision. Second by Ron Hepner. With all in favor, motion carried.
