

Upper Paxton Township Board of Supervisors
Monthly Meeting
October 23, 2024

Those in attendance: Robert Stoner, Bob Coleman, and Rich Wiest, Supervisors; Luanna Zimmerman, Secretary/Treasurer; Joe Underkoffler, Rodney Lebo, Rhonda Lebo, Doug Moran, and Elaine Moran.

The meeting was called to order by Chairman Stoner at 10:00 a.m. All present recited the Pledge of Allegiance to the flag. Robert Stoner made a motion to approve the minutes from the September 25, 2024, meeting. Second by Bob Coleman. With all in favor, motion carried. After reviewing the list of bills to be paid, Bob Coleman made a motion to approve the bills for payment. Second by Rich Wiest. All in favor, motion carried. Bob Coleman made a motion to approve the bills paid on 10-15-24. Second by Rich Wiest. With all in favor motion carried.

Public Comments: None

Roadmaster's Report: Rich Wiest said that the roadcrew has been busy with the following items: cleaning up of the compost lot after WW Pallet ground and hauled away the debris, leaf vacuuming, and installed inlet boxes and piping to manage the stormwater around the new salt shed. Wiest provided the Board with a quote of \$10,042.00 for curtains for the salt shed. Bob Coleman made a motion to purchase the curtains out of the 2024 budget if possible. Second by Robert Stoner. All in favor motion carried. Robert Stoner asked about a stormwater issue off of Rising Sun Lane. Rich Wiest provided information on a possible fix and said that he will contact the property owner and let them know the issue will be addressed in the spring of 2025. Rodney Lebo inquired about additional work to be done on Snyder Mill Road. Wiest informed him that the work could possibly be done this winter or next spring.

Old Business:

1. The Millersburg Senior Center Emergency Shelter Project was discussed. It was decided to put money into the 2025 Budget for a contribution to the project.
2. Joe Underkoffler provided the Board with an update on the Upper Dauphin COG EMS Study. Underkoffler said he had attended a recent meeting with Rich Wiest, Bob Coleman, representatives from the Millersburg Ambulance Association, and Robb Consulting. Underkoffler said the study is still in process and that Robb Consulting will have a report with their findings and recommendations to the municipalities in the first quarter of 2025.
3. The Board discussed budget categories and amounts for the 2025 Budget. After discussion Robert Stoner made a motion to advertise the 2025 Budget. Second by Bob Coleman. With all in favor, motion carried.

New Business:

1. The Board reviewed a quote from Sean Grimm in the amount of \$10,130.65 for EMA radios. It was decided to account for that expense in the 2025 budget.

Robert Stoner made a motion to adjourn the meeting at 11:32 a.m. Second by Bob Coleman. All in favor, motion carried.
