

**Upper Paxton Township Board of Supervisors
Monthly Meeting
July 23, 2025**

Those in attendance: Robert Stoner, Bob Coleman, and Rich Wiest, Supervisors; Luanna Zimmerman, Secretary/Treasurer; Joe Underkoffler, Rodney Lebo, and Doug Moran.

The meeting was called to order by Chairman Stoner at 10:00 a.m. All present recited the Pledge of Allegiance to the flag. Rich Wiest made a motion to approve the minutes from the July 8, 2025, meeting. Second by Bob Coleman. With all in favor, motion carried. After reviewing the list of bills to be paid, Bob Coleman made a motion to approve the bills for payment. Second by Rich Wiest. All in favor, motion carried.

Public Comments: None

Roadmaster's Report: Rich Wiest said the roadcrew has been busy with the following items: Grading gutters on roads to be paved and roads with water issues, cleaning pipe inlets and outlets, completed a repair at Woodside Road and Wagon Road, and cleaned up tree limbs after storms. Wiest also said that almost 500' of pipe needs to be replaced on Romberger Road. Bob Coleman said the original pipe on Romberger Road was installed in the 1980s.

Old Business:

1. Bob Coleman provided the Board with information on the COG EMS Study. Coleman said that Robb Consulting recommended that the municipalities involved be separated into small groups. Each small group would choose one representative. Those individuals will form a committee to figure out how the funds will be generated to support EMS in Northern Dauphin County. Supervisor Wiest said he believes they are leaning toward an Authority that will collect the funds and distribute them to the EMS Companies. Robert Stoner pointed out that the Fire Companies and the Ambulance Associations are two very different entities and that we are committed as a township to see where this goes.
2. Bob Coleman suggested Upper Paxton Township host a meeting to discuss the Tanner's Run stormwater issues and possible repairs. A date of August 19, 2025, at 9:00 a.m. was set. Luanna Zimmerman was asked to advertise the meeting in The Citizen Standard and email various people & organizations to make them aware of the meeting.

New Business:

1. Grants, such as Chesapeake Bay funding and Local Share Account Statewide (Department of Community & Economic Development), to fund repairs for the

Tanner's Run stormwater issues were discussed. Chairman Stoner said this will be put on hold until after the meeting on 8-19-25.

Bob Coleman said that he and Rich Wiest had met with township engineer Keith Heigel to discuss the south end of Tanner's Run. The Board unanimously agreed that Light-Heigel should be employed to provide them with water calculations (water flow and collection) and options to fix the problem.

Public Comments: None

With no further business on the agenda, Robert Stoner made a motion to adjourn the meeting at 10:52 a.m. Second by Bob Coleman. With all in favor, motion carried.
