**Part 1**

**Sewer**

**§1. Franchise to Millersburg Area Authority.**

This Township does grant to the Authority, its successors and assigns, all easements, rights of way and other rights necessary and desirable in, along, over and under streets, roads, lanes, courts, cul-de-sacs, alleys, public ways, public squares and other properties of this Township, together with free ingress, egress and regress therein and thereto, along with other persons having interests or rights therein, for use in connection with constructing, replacing, repairing, altering and maintaining the sewer system to be acquired and constructed by the Authority, as the same shall exist, from time to time.<sup>1</sup> (Ord. 5-28-76-B, 5/28/1976, §1)

**§2. Regulations Authorized.**

The rights and privileges granted to the Authority under §1 shall be exercised by the Authority under and subject to such reasonable rules, regulations and conditions as shall be adopted and specified, from time to time, by resolution or ordinance of this Township; and this Township does reserve the right to adopt and specify, from time to time, such reasonable rules, regulations and conditions in connection with exercise by the Authority of such rights and privileges. (Ord. 5-28-76-B, 5/28/1976, §2)

**§3. Severability.**

In the event any provision, section, sentence, clause or part of this Part 1 shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Part 1, it being the intent of this Township that such remainder shall be and shall remain in full force and effect. (Ord. 5-28-76-B, 5/28/1976, §4)

**§51. Franchise to Millersburg Area Authority.**

This Township does grant to the Authority, its successors and assigns, all easements, rights of way and other rights necessary and desirable in, along, over and under streets, roads, lanes, courts, cul-de-sacs, alleys, public ways, public squares and other properties of this Township, together with free ingress, egress and regress therein and thereto, along with other persons having interests or rights therein, for use in connection with constructing, replacing, repairing, altering and maintaining the water system acquired and constructed by the Authority, as the same shall exist, from time to time.<sup>2</sup> (Ord. B-12-75, 12/17/1975, §1)

**§52. Regulations Authorized.**

The rights and privileges granted to the Authority under §51 shall be exercised by the Authority under and subject to such reasonable rules, regulations and conditions as shall be adopted and specified, from time to time, by resolution or ordinance of this Township; and this Township does reserve the right to adopt and specify, from time to time, such reasonable rules, regulations and conditions in connection with exercise by the Authority of such rights and privileges. (Ord. B-12-75, 12/17/1975, §2)

**§53. Severability.**

In the event any provision, section, sentence, clause or part of this Part 2 shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Part 2, it being the intent of this Township that such remainder shall be and shall remain in full force and effect.
